# Rescinding the Right to Abortion

# Dobbs v. Jackson Women's Health Organization (2022)

Mississippi enacts law banning abortion after 15 weeks except in narrow cases of medical emergency or "severe fetal abnormality" After district court & 5<sup>th</sup> Circuit find Mississippi law unconstitutional (per *Roe v. Wade*), U.S. Supreme Court agrees to hear the case

# *Held:* the Constitution no longer confers a right to abortion.


On June 24, 2022, the Court issued its decision, fully overturning *Roe v. Wade* & *Planned Parenthood v. Casey*



Estimates of abortions in the United States



## Post-Dobbs Abortion Access: Open Doors

#### PATHWAY:

This Primer describes a series of "open door" legal pathways to access abortion services in the U.S. in light of the withdrawal of federal rights to abortion in Dobbs and restrictive state abortion laws.

#### **COVERAGE:**

Coverage explains who may be able to utilize a specific pathway to access abortion services.

#### **CAVEATS:**

Caveats delineate various actual or potential limitations related to accessing abortions via each pathway.





### PATHWAY

FDA's authority to approve safe & effective drugs for circulation in interstate commerce <u>may preempt</u> contradictory state laws seeking to limit or restrict medication abortion access, enabling access to medication abortion nationally.

### COVERAGE

Pregnant individuals seeking abortion <u>up to 10 weeks</u> <u>gestation</u>.

### CAVEATS

Litigation may determine the extent of FDA preemption vis-àvis state authority over the practice of medicine.





## **Expanded Medication Access**

#### PATHWAY:

Some physicians may prescribe mifepristone (medication abortion pill) offlabel to pregnant individuals seeking abortion <u>past the FDA-approved 10</u> <u>weeks gestation</u>, as <u>current WHO guidelines</u> favor prescribing up to 12 weeks gestation. Some providers also may prescribe mifepristone & misoprostol via advance provision to individuals at risk of unintended pregnancy. States may also consider <u>expanding the classes of clinicians</u> authorized to provide medication abortion.

#### **COVERAGE:**

Pregnant individuals seeking abortion up to 12 weeks gestation or individuals at risk of unintended pregnancy.

#### **CAVEATS:**

Access may vary based on individual physician discretion or <u>increased state-level restrictions</u>. Many physicians prescribing up to 12 weeks or as advance provision only provide care via telehealth services, which may be subject to other limits.





# **Employer Travel Benefits**

### PATHWAY:

Private companies may <u>cover travel costs</u> for employees or dependents living in states that restrict abortion access. Travel costs <u>could be provided</u> as travel benefits covered through existing health care plans, as direct reimbursement, or through standalone funds.

#### **COVERAGE**:

Certain employees or dependents who must travel out-of-state to access abortion care.

#### CAVEATS:

Litigation may determine if funds used for these purposes may violate state <u>aiding & abetting</u> <u>provisions</u>. Health care plans may face <u>state</u> <u>restrictions</u> if fully-insured, rather than self-funded. Expanded benefits <u>may not cover part-time or</u> <u>hourly workers</u> under existing health care plans.





# **Medicaid Waivers**

#### PATHWAY:

President Biden & the Department of Health & Human Services have expressly encouraged states interested in expanding or protecting abortion access to apply for <u>Section 1115 waivers</u> of Medicaid requirements to potentially receive federal funding for programs designed to help cover travel-related costs for Medicaid recipients seeking abortions across state lines.

#### **COVERAGE:**

Medicaid recipients seeking abortions across state lines.

#### CAVEATS:

No state has yet applied for a waiver, possibly due to the <u>complex application process</u>. The <u>Hyde Amendment</u> bans the use of federal funds to pay directly for abortions, so individuals still need additional funding to pay for the procedure.





# **Telehealth**

#### **PATHWAY:**

Telehealth is a <u>safe</u>, available avenue to access medication abortion (<u>mifepristone</u> & <u>misoprostol</u>) enabling physicians to prescribe drugs & provide follow-up care via telehealth consultation. In abortion-hostile states, patients <u>may be able to obtain a prescription using telehealth services</u> which is then filled at an out-of-state pharmacy mailed to or picked up by the patient in an abortion-protective state.



### **COVERAGE:**

Pregnant individuals up to 10 weeks gestation, with some providers prescribing through <u>12</u> weeks.

#### CAVEATS:

<u>FDA previously limited dispensation of mifepristone to use under physician</u> supervision, though <u>FDA recently moved to modify this stringent control</u>. Drugs are only available in states legalizing abortion, subject to litigation. Pharmacies dispensing mifepristone must be <u>certified</u>.



# **Mobile Clinics**

### PATHWAY:

Private organizations including <u>Just the Pill & Planned</u> <u>Parenthood</u> may operate mobile clinics inside vehicles located near abortion-hostile state borders for medical & <u>surgical abortion options</u> (in limited cases). Access is currently <u>available in CO</u>, in development in <u>IL</u>, and there are plans to extend access in <u>CA, NM, NY & WA</u>.

#### **COVERAGE:**

Varies depending on site, provider & state law.



#### **CAVEATS:**

Uncertain <u>interstate criminal or civil liability</u>. Limited availability of mobile clinics. Patient & staff <u>safety concerns</u> & travel <u>costs</u>.





### **International Access**

#### **PATHWAY:**

Dozens of countries have legalized abortion access, including <u>Canada</u>, which has offered to serve as a "safe haven" for Americans to access abortion. Discreet clinics in Mexico (e.g., <u>Tijuana</u>) are providing access as well. <u>Aid Access</u>, based in the Netherlands, ship <u>abortion medications</u> to patients in need around the world from a pharmacy based in India.

#### **COVERAGE:**

Varies depending upon country of access; generally pregnant individuals ranging up to 24 weeks gestation depending on method.

#### **CAVEATS:**

Patients must cover travel & procedure <u>costs</u> <u>in full</u>. There are extensive <u>waitlists</u> & mailing internationally adds <u>shipping delays</u>. Some state laws ban mailing abortion pills, subjecting patients to threatened enforcement.





#### PATHWAY:

Many states require parental consent or notification before a minor can access abortion care. <u>15 states</u> (CA, IL, NM, WA, etc.) & Washington, D.C. do not require parental consent for abortion for minors. <u>"Judicial bypass,"</u> court approval for abortion access in place of parental consent, may be an option in <u>35 states</u>.

#### **COVERAGE:**

Pregnant minors under the age of 18.


#### **CAVEATS**:

Parental & minor consent requirements vary; travel access & costs; judicial bypass laws vary across the states; liability concerns.

#### Factoring parents' consent in abortion

Thirty-five states require either parental consent or notification for a minor to have an abortion. Five states have laws that require the involvement of both parents.

# **VA Beneficiaries**

#### **PATHWAY:**

In a September 2022 <u>memorandum</u> from the Department of Veterans Affairs (VA), the VA clarified its <u>Interim Rule</u> allowing its employees to provide abortion services to VA beneficiaries in select circumstances, i.e., "when the life or health of the pregnant individual would be endangered if the pregnancy were carried to term or when the pregnancy is the result of rape or incest."

### COVERAGE

Covered abortions for <u>pregnant</u> <u>veterans & VA beneficiaries</u>.

### CAVEATS

Potential litigation; since the <u>VA had not</u> <u>provided abortion services</u> prior to its issuance of the Interim Rule, it will <u>take time</u> to implement the infrastructure necessary to facilitate provision of abortion services.





# **Enforcement Discretion**

#### PATHWAY:

Prosecutors have near-absolute discretion over when to prosecute individuals for abortion-related crimes. Post-*Dobbs*, <u>90+ elected state</u> <u>prosecutors</u> have pledged not to enforce their states' abortion bans or restrictions. Some <u>police chiefs</u> & <u>city councils</u> have also issued memos providing for the de-prioritization of police enforcement of abortion bans.

#### **COVERAGE**

Highly variable & dependent on jurisdiction.

### CAVEATS

Governors can suspend prosecutors for refusing to prosecute abortions. Prosecutors are elected officials with fixed or limited terms—newly elected prosecutors may take different stances from their predecessors.





# **Gubernatorial Pardons**

### **PATHWAY:**

State governors who disagree with state laws limiting or criminalizing abortion may pardon or grant clemency to individuals found in violation of these laws. Wisconsin Governor Tony Evers <u>offered to grant clemency to physicians</u> prosecuted for providing abortions in the state.

### COVERAGE

Highly variable; dependent on where one lives.

### CAVEATS

Newly-elected governors may choose not to grant pardons; state governors would not be able to pardon federal crimes.





### Pharmacies' Nondiscrimination Obligations

#### **PATHWAY:**

Post-*Dobbs,* the number of individual pharmacists <u>refusing to dispense</u> certain medications has increased, due to both personal beliefs & fears of prosecution under strict abortion bans. However, federal civil rights laws <u>ensure access</u> to comprehensive reproductive health care services. Under <u>Affordable Care Act</u> <u>§ 1557</u> & <u>Rehabilitation Act § 1557</u>, pharmacies cannot discriminate against persons by refusing to dispense medication as prescribed by their physicians.

#### COVERAGE

Any patient who has been prescribed misoprostol, mifepristone, or methotrexate.



#### CAVEATS

Anti-discrimination protections for pharmacists' religious beliefs under the <u>Civil Rights Act Title VII</u> may support refusals to fill a prescription for medications that could be used to induce abortions. Persons (including <u>corporations</u>) may assert antidiscrimination protections as well under federal or state <u>Religious Freedom</u> <u>Restoration Acts</u>.



## Emergency Medical Treatment & Active Labor Act (EMTALA)

### PATHWAY:

EMTALA requires most U.S. hospitals to provide screening & stabilizing emergency care. On July 11, 2022, <u>HHS confirmed</u> that physicians may conclude life-saving abortion care is necessary under EMTALA when pregnant patients present with an "emergency medical condition" (EMC). <u>EMTALA expressly</u> <u>preempts conflicting state laws</u>.

#### **COVERAGE:**

Pregnant patients with an EMC necessitating abortion as treatment at most hospitals.

#### **CAVEATS:**

Litigation may determine what is considered an EMC or how state & federal laws intersect. In select challenges (TX, ID), federal courts have issued contradictory opinions.





## **Active Military Access**

#### **PATHWAY:**

The <u>Under Secretary of Defense released a memo</u> on June 28, 2022, stating that service members, dependents, other beneficiaries & Department of Defense civilian employees <u>may continue to access</u> <u>"covered abortions"</u> (e.g., if the life of the mother would be endangered if the fetus were carried to term, or if the pregnancy is the result of rape or incest). Active-duty service members may still travel to receive abortion care, not limited to covered abortions.



#### **COVERAGE:**

Service members seeking "covered" abortions or traveling for abortions.

#### CAVEATS:

The military installation must have a medical facility <u>capable of performing abortion services</u>. Service members must seek to take leave to travel for abortions not covered under federal law or if the installation is incapable of providing an abortion. <u>Obtaining leave can be difficult</u>. TRICARE is only available for covered abortions. Thus, if granted leave, there are great <u>financial</u> <u>barriers in travel & abortion service expenses</u>.



# **EUA/PREP Declaration**

#### PATHWAY

HHS may have authority to issue an abortion-related <u>Public Readiness & Emergency</u> <u>Preparedness (PREP) Act Declaration</u>. A PREP Act declaration could convert misoprostol into a covered countermeasure. FDA may issue an <u>emergency use</u> <u>authorization (EUA)</u> to allow unapproved uses of approved drugs, like misoprostol for inducing abortions, rather than its approved use for prevention of NSAID-induced gastric ulcers. A PREP Act Declaration & an EUA may <u>provide strong liability protections</u> for losses due to the covered countermeasure as well as protections for persons or entities administering or providing the countermeasure.



### COVERAGE

Pregnant patients potentially seeking to use misoprostol up to 10 weeks gestation.

#### CAVEATS

HHS & FDA have not issued a PREP declaration or EUA. Because a PREP Act & EUA would provide a federal liability shield, there may be <u>state litigation regarding the</u> <u>extent of the liability protection</u> under the Act. Since <u>mifepristone is already FDA-</u> <u>approved</u> for abortion, it is less likely to receive potential EUA and PREP Act coverage.



# **Emergency Contraception**

#### PATHWAY

While not a pathway or substitute for abortion access, Americans still maintain a fundamental right to use birth control. FDA has approved 4 emergency contraception products (e.g., Plan B, *ella*, oral contraceptives, IUDs) which can be taken shortly after unprotected sex to prevent pregnancy. While most require a prescription, Plan B is sold over-thecounter. The Affordable Care Act (ACA) requires most private health plans to cover FDA-approved emergency contraceptives. Online platforms allow individuals to obtain emergency contraception without an in-person appointment.

#### COVERAGE

Individuals who have had unprotected sex in the last 3-5 days.

#### CAVEATS

Some states have <u>restricted</u> emergency contraceptive access; litigation may ensue regarding <u>contraception/abortion definitions</u>.
